CEPEJ adopts guidelines on videoconferencing in judicial proceedings



The European Commission for the efficiency of justice (CEPEJ) of the Council of Europe adopted guidelines on videoconferencing in judicial proceedings at its Plenary meeting in June 2021. The guidelines include also proposals for the use of evidence giving experts during the remote hearings and can be found on the CEPEJ Website.

Czech Standards for reports and the valuation of property



Our Council member Vladimir Kulil informs about current standards for experts in the Czech Republic. According to Czech legal regulations, every oral and written expert opinion must be true, which is a unique requirement that does not occur in other valuation standards. Satisfiability is problematic because Truth is a philosophical concept and is often defined as a subjective reflection of objective reality. Thus, there is the possibility of a different subjective view of the truth by each expert. Therefore, in

Czech law, the requirement is a thorough requirement regarding the veracity of the input data, their proper justification and the possibility to determine the result in the price range.

European Commission publishes EU Justice Scoreboard 2021 – Digital Expert Evidence needs more consideration



The EU Commission published the Scoreboard 2021 in July. For the first time, the Scoreboard gives information of how advanced judicial authorities manage the digital transformation. Following the EU Commission, the findings would show that in almost all justice systems videoconferencing systems were used and kept courts functioning during the COVID-19 pandemic. The figures show that experts can be heard by distance communication technology in nearly all types of cases and EU Member States. Different from notaries and lawyers no data has been provided on the availability of secure electronic communication between courts and experts for proceedings.

Austria has a system of sworn and court-certified experts which is unique in Europe - both for the judiciary and for society.

Being embedded in our legal system, court experts are "auxiliaries of the judiciary" or "advisors of the judge" in a technical context and they are therefore given a special place in court proceedings by legislation, both in civil litigation and in criminal proceedings.

This special position entails great responsibility, which court experts must live up to in all respects, it also ensures that they are not only highly qualified and skilled professionals, but also enjoy trust in their economic and societal environments outside of court and that their independence is beyond doubt.

Federal Ministry of Justice in Berlin is planning a statutory rule regarding complaints about publicly certified experts



The BVS (German Association of Publicly Certified and Qualified Experts) has been informed by the Federal Ministry of Justice and Consumer Protection that they plan to introduce a statutory rule regarding complaints about publicly certified experts in order to inform the various chambers responsible for the appointment of publicly certified experts about the misconduct of said experts. Through such a legally regulated power of notification, the chambers, meaning the chambers of commerce and industry, chambers of crafts, chambers of architects, chambers of engineers und chambers of agriculture, could be notified about any misconduct of the experts they appointed. Therefore, the chambers could thusly be enabled to react with consequences according to vocational law.

CEPEJ Cyberjustice and Artificial Intelligence working group decides on future priorities



The European Commission for the efficiency of justice (CEPEJ) of the Council of Europe set up a working group on Cyberjustice and Artificial Intelligence (CEPEJ-GT-CYBERJUST) in 2019. In its 4th Meeting in September 2021 the working group decided on work priorities (Roadmap). These include "From paper files to e-files", On-line Dispute Resolution (ODR), On-line enforcement procedures and remote hearings. All areas will also influence the work of experts.
